**Camp Payments:** Tuition is an annual payment and is divided into 2 equal monthly payments beginning June 15<sup>th</sup> – July 15<sup>th</sup>. All tuition must be processed through Tuition Express. A late fee of \$25.00 will be assessed to a past due account on the 25<sup>th</sup> of the month.

**Late Pick-up Fee:** Families will be charged \$25.00 for every 15 minutes they are late to pick up their child.

**Camp Calendar:** The camp is closed on July 4<sup>th</sup>. Drop off is 8:30 am and pickup is 6:00 pm. Friday pickup is 5:30pm.

**Camp Enrollment Fee:** Enrollment forms must be accompanied by a \$125 enrollment fee per family (for members) or a \$150 enrollment fee per family (non-members).

**Termination of Contract and Withdrawal of Student:** The school may request that a child be withdrawn from the program for:

1. Non-payment of accounts with 14 days of the due date, unless prior arrangements have been made with the Early Childhood Director.
2. Consistently unacceptable behavior that jeopardizes the safety of the child or other;
3. Lack of required documentation (health/immunization records, admission agreement and or/Tuition Express agreement within the set time frame.
